# ALASKA'S GOT TALENT – CONTEST RULES

These rules serve only for the ALASKA GOT TALENT Contest. The Grand Prize consists of \$500 cash and \$500 gift card from Mammoth Music split between the two categories and an opportunity to perform at The Whaler Bar & Grill for performer over the age of 21 year.

Contests must be a resident of the State of Alaska.

This prize has no cash value. Prize is non-transferable.

To be a finalist in Alaska's Got Talent, the contestant must participate at The Northway Mall on 7/17/10. One contestant will be chosen from two categories. Under 21 and 21+.

Contestants may bring their own music, but are highly encouraged to have it in karaoke format (i.e. with no vocals). The song performed must be approved by AMG staff. Performers' time will be appropriately regulated so that all participants have an adequate chance to compete.

1. AMG and Northway Mall reserves the right to revise these rules at any time.
2. Registration is on a first-come first-serve basis, with a guarantee of 20 participants. Those who wish to participate past the 20 allowed participants may be put on a waiting list for that week only on a time-allowable basis. Advance registration is required.
3. Contestants must abide by all state and federal laws while participating in the contest.
4. Musical instruments played by the contestant are allowed, to the limits of KBEAR staff discretion.
5. Judges will consist of local personalities and talent, as well as an AMG affiliated member. Because of the demographic of Anchorage, it is possible that judges may know contestants outside of the contest; impartiality will be observed on these occasions.
6. All entrant participation in this contest is voluntary and acknowledges that, AMG and other participating sponsors are not responsible for any liabilities arising directly or indirectly from participating in this contest.
7. All participants grant AMG irrevocable consent in perpetuity to the use of the sound recordings, photographs, video tape, and illustrations taken during or in connection with the contest, in any and all applications including but not limited to advertising, commercials, promotion, stories, text, articles, illustrations, copy and commercial exploitation, in any and all media forms at any time without the winner's further knowledge or consent.
